### **“I’m sticking with my union!”**

President’s Message - David Freeland

You’re going to be seeing this slogan a lot in the coming months. It is the message we need to send to the Florida Legislature and Governor as they continue their relentless attack on public education, with their most recent attacks on our union and local school boards.

The latest from the Governor’s office is the Teacher’s Bill of Rights which tries to convince us that we were tricked into joining our union, that we didn’t choose to join our union, and that we need his protection.

The document also attempts to convince us that he and the legislature will work to protect educators’ rights better than their union can and will. Remember these are the same people who have spent the last several years working to convince parents that we all are teaching a secret curriculum, that we tried to close schools during COVID, and most recently that we are pedophiles and groomers.

I’m sticking with my union for a reason. It is impossible to separate educators from their union, to say, “I love educators” and then say, “I hate their union”. You can’t have one without the other. The union is educators, and educators are our union.

In 1968 our colleagues advocated for themselves, and ultimately for all of us and our students; for people they didn’t know and some who weren’t even born yet. They chose to make a stand, to take big risks, to walk out and tell legislators, “Enough is enough” and “This isn’t good enough for us or our students”.

What our colleagues won in 1968 was a legacy of unions and workers’ rights, the right to collectively bargain, the right to protect our profession and our students. *The deal that was struck was that the legislature would grant to us the **Constitutional right** to collectively bargain, to join a union if we chose to, and in return, we would not go on strike.*

Our legislature and governor have continually broken that agreement – the latest being the attempt to eliminate payroll deduction and to increase to 60% density (percentage of union members out of our total potential) as the threshold to remain certified as a union. All of which are ways in which they seek to eliminate our very existence.

I am not advocating that we go on strike; as a union leader in Florida I can’t do that. What I am advocating for is three things. First that we do what we do best as educators – *we educate the public about the work we really do, and that we chose to be members in our union*. Second, that you take the time to fill out the surveys and forms that you will be receiving in the next weeks as we convert to EZ Pay so that you can continue to pay your union dues easily and with minimal fuss. Third, that you answer your union’s call to action. WE are the union. ALL of us, and we have to unite to push back on bad policies.

Once we move members to this new system, they should see no difference in how their dues are deducted and the entire Association will enjoy several benefits. You will hear more details shortly, but these two things: educating our friends, family, and neighbors, as well as responding right away to your union’s surveys and documents, are the best ways to protect the rights our colleagues fought so hard to get for us and that our union continues to protect for us to this day.

**SPOTLIGHT ON HB1557**

As a union worksite leader, LGBTQAI+ ally, and sponsor of the student chapter of Fort Pierce Central's Gay-Straight Alliance (GSA), Florida's House Bill 1557 hit hard.

To some, the Parental Rights in Education Act of 2022 put more control in parents' hands, while others felt increasingly marginalized, left stripped of basic human rights, and less safe. For teachers, the risks for supporting vulnerable student populations, created increased pressure and scrutiny.

In December 2022, the Florida Education Association hosted a LGBTQAI+ presentation to train and inform members of the implications of HB 1557. The main take-aways are that all students deserve to feel safe, comfortable, and seen as valuable individuals in schools. In third grade and below, conversations are restricted regarding sexual orientation and gender identity. Conversations of this nature should also be gauged appropriately by age and maturation, including individuals with cognitive disabilities.

As there are many nuances for legal tethers, as it currently stands in SLC - members, if a student requests to use another name or pronoun in your class, consider honoring the request. The confidence and bravery it took the student to ask demonstrates trust in you. Inform the student that if directly asked by administration or families, you the educator, are required to disclose the alternative identifiers. Find a comfortable time and place to have a conversation to encourage the student to share their request with their families.

If you do not feel comfortable having these conversations, it is ok. Contact an ally on your campus, your guidance department, or April Mincey who is an ally at the district.
